Recently, two disappointing violations of our copyright have come to our attention. In the first, an employee of a large pharmaceutical manufacturer downloaded an issue from our web site, made copies and sent them to about 3000 colleagues. In the second, a medical school librarian at a state university posted a notice on the library's web site offering all patrons of the library a user name and password for The Medical Letter, obtained for the cost of a single subscription. Both of these subscribers, when applying for electronic access, had agreed (responded "Yes") to our Terms and Conditions, which do not permit these practices.

We ask our readers to respect our copyright. We offer electronic access to our issues to individual subscribers and, for a reasonable fee, site licenses for electronic access to organizations like pharmaceutical companies and universities.
